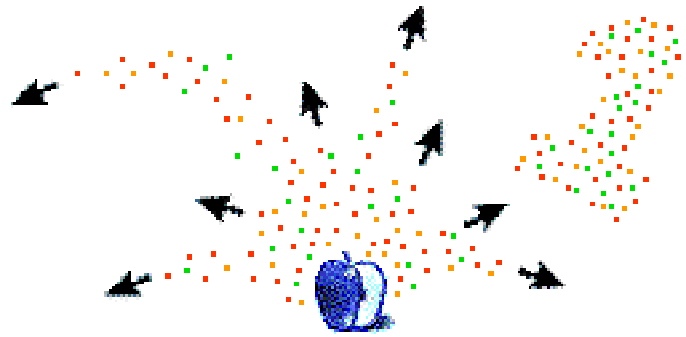

I signed up for a second account with America Online the other day. I dug through the trash for one of those ubiquitous AOL disks, threw the first two I found back (they were for Windows) and popped the third into the computer. I loaded the software, started it up, and went through the sign-in process. When I entered my credit card information, however, it stopped, told me to call Customer Service, and hung up.

I called, dreading a two-hour phone wait. But the AOL customer service people were friendly.



speedy, and apparently from Brooklyn. (I used to live in New York, I can recognize the accent.) She told me that they ask you to call Customer Service because they want to make sure you realize you'll be getting two monthly charges to your credit card. I said yes, and she told me to sign on.

Unfortunately, "ATPM" is still unavailable as a screen name on America Online, and I can't think of another name I want to use as the primary account name.

Oh, and a funny story about AOL (the service I love to hate). Sunday night, I was watching TV and one of those annoying AOL commercials came on. The wholesome guy turns to me and says, "A friend of mine told me I should try America Online, and I said, 'But I already have a computer!'" What does that mean? In any case, at the same time as this commercial was playing, Tiffany was logging on to AOL at the computer, and the service was failing, telling her to please try again in fifteen minutes.

Oh, and I almost forgot. On April 1st I called up AOL on my main account and it wouldn't let me on. It said my password was invalid. Hello? I hadn't changed it, so I was very suspicious. I called the 800 number offered by my AOL software and got a very helpful person who was more than happy to change my password to something else, if I would only give her my name, address, and credit card number...

They have content geared towards environmental topics, including specific action items and headlines, and a number of environmental groups have accounts with them. When I needed to get in touch with the World Wildlife Fund, they had an account right there. But now I don't need their services, and frankly, they charge too much. Next!

eWorld. Don't get me started. I had great hopes for the little online service that thought it could. You could almost hear the whispers every time you logged on, "I think I can, I think I can, I think I can..." Alas, in the end it couldn't. 150,000 active member in two years just wasn't enough to convince Gil Amelio, Apple's new CEO, that the world needed another online service. I humbly present that, while the world does not need another online service (visit the Web recently?) it could just benefit from a real online community, which is what eWorld was shaping up to be.

A moment of silence if you would.

Now I have only three online accounts. One on AOL, one on Nfinity, and my old one on

CompuServe. I feel kind of silly when I open Emailer now. Where I used to have account after account, I don't any longer. I still get a ton of mail, mind you, but it seems very impersonal now.

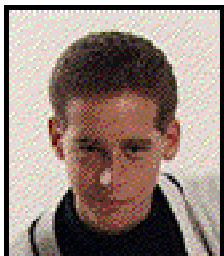
instinctively knows the difference between a rip-off and the real thing.

## On the Front Lines

# The Hullabaloo in Cupertino

---

It's amazing, isn't it? Human nature, that is. The fact that when a group of people has something good, those who have not want to band together and destroy it utterly. Call it jealousy, call it immaturity, call it evil. Whatever it is, it's what has driven critics of the Macintosh platform for more than a decade. And this past year has been no exception.

“The Fall of an American Icon,” proclaimed an alarmist headline from what used to be a reputable news magazine. Stock downgrades from Merrill Lynch, among other major investment firms. Allegations that Windoze ‘95 has leveled the playing field. Let me take these one at a time for you, and show you just why these familiar stabs at Apple are so unfair, incorrect, and just plain cruelty without cause.

“The Fall of an American Icon.” This was proclaimed after Apple announced a loss of \$60 million. That’s sixty million. A six, followed by seven zeros. Apple is a company worth roughly eleven BILLION. That’s the number eleven, followed by NINE ZEROS. Those of you who know even basic math are aware of what a HUGE difference that is. More importantly, Apple had, at the time, close to one BILLION dollars in CASH on the ledgers. That means they had more than enough to absorb that loss, and yes, even the \$700 million one they just announced recently. I hate to annoy the BusinessWeeks of the world, but Apple isn’t going anywhere soon. Slam them all you want to in the headlines.

One thing about the alarmist headlines that really gets to me is how the same media that naysays Apple refuses to acknowledge crisis when companies like Compaq lose more than eighteen points in one day on the stock market. Or when IBM took a hit a few years back for several BILLION dollars, laying off more than 10,000 people. Or when other major computer manufacturers like Packard Bell say that things aren’t as good as they used to be, and scale back production and lay off workers. But have a bad day in Cupertino, and man oh man, it’s the end of the world.

If I sound mad here, it’s because I am.

What about the stock downgrades? Merrill Lynch downgraded Apple’s rating several times last year, each time citing reasons such as “dwindling market share” (wrong-it’s fluctuated at worst, but rarely if ever dropped lower than seven percent in the last five or six years), “an installed base of only 20 million customers” (first, wrong...it’s 22 million just in the U.S., not 20, and 56 million worldwide, second-they forget to mention that more than 19 million of those will repurchase a Macintosh when theirs becomes outdated, and that nearly two million more will be first-time users. They also fail to mention a loyal and market-leading educational base, as well as digital film and audio editing, both of which are dominant Mac markets) and “dwarfing by other computer platforms, namely Wintel.” (okay, this one is actually correct. But Coke outsells Pepsi worldwide by an almost 9-to-1 margin, and you don’t see Pepsi dying off.)

So if only one of these three arguments is actually able to hold water, then how can a supposedly responsible financial giant like Merrill Lynch downgrade Apple’s buy recommendation? Simple. Because they want to. Why? Because of corporate pressure from giants like Microsoft and Compaq who can offer perks and large commissions on the sale of their stock to brokers. They are encouraged to downgrade Apple by these folk, and when there’s a buck to be made, downgrade they shall.

It’s interesting to note that on the day that Apple first announced a possible \$700 million loss, its stock actually rose 5.76%, on a day when Compaq only rose 1.71%, IBM .45%, and Microsoft lost .24%. Yes, all those companies have higher stock prices than Apple, so small changes would mean smaller percentages, but the computer market tends to dip and sway as a whole, and not everyone did so well that day. Analysts felt Apple’s stock increased with the announcement, because investors felt Amelio was doing the right thing by taking the whole enchilada on the chin this quarter. Investor confidence in Apple is rising with Gil’s tenure as CEO. Too bad the investment firms don’t feel the same.

Finally, what about the allegations that Windoze ‘95 has leveled the playing field? Well, that’s a good question. Most Mac users will still scratch their heads in amazement that a PC user could be enthralled with something so non-intuitive. It isn’t the MacOS by a longshot. Even PC World

magazine reported that the MacOS was rated highest in their independent test...over Windows 3.1, Windows '95, OS2Warp, and even Windows NT. That's right...PC World. People using the MacOS still get more done in less time with fewer problems than folks using non-Mac operating systems. Does that sound like a leveled playing field to you? Microsoft might be catching up, but if you see the competition's back, as my father says, you're still behind. Even if you can count the hairs.

Windows '95 is, in my own opinion, such a humongous improvement over 3.1, that if you had asked, I wouldn't have even guessed that they both came from Microsoft. However, I would still be asking questions like "What does .ini stand for?" and "why doesn't anything happen when I click on this start button?" Intuitive, it ain't. I had to use 3.1 before, in my job at the time, and I will admit that if it were the only thing I had ever seen, '95 would be like a miracle. But my feeling on the matter is this: the improvement is so great, the critics hate to admit that as good as it is, it still can't compare to what amounts to a decade-old operating system. It hurts too much. Bill Gates puts all this effort into his new baby, and it still winds up being just second best in terms of usability and efficiency. When you own a PC, that's the last thing you want to believe. And you can take that to the front lines.

# How **COOL** is Your Mac?

It's been a year since that first issue of *About This Particular Mac*. Of all the articles we've published in that year, one has been more popular than any other, generating mail even today. That article appeared in the very first issue of the magazine, and was called "How Cool is Your Mac?" In it, I tried to inject a little humor into the trials of deciding when to upgrade your computer.

In the spirit of anniversary recollection, I have updated and reprinted the article for this issue. I hope you enjoy it just as much this time around.

Bewildered by the vast array of computers out there? Don't know if you need PPC? PCI? Should you buy from PCC? Need PCMCIA capability? You want help? Well, we're not here to tell you what to buy, but we'll give you a helping hand on your way. This is the one-of-a-kind ATPM Coolness Factor rating system.

It's very simple. You take your computer, and you go through the list, tallying points as they apply to your setup. And the end you'll have a Coolness Factor for your computer system. Then you do the same for the system you are looking to buy, and you compare Coolness Factors. If you're really into it, you can have a contest at school, though we suggest an impartial judge decide on the merit of each entry. ("But, why can't I count all of my Apple branded t-shirts as accessories?")

## Out of the Box

- **1 point** for being a computer. They are inherently cool.
- **1 point** if it has a colorful, rainbow-striped apple on the outside. After all, we pay for it, we might as well reap some benefit. Remember, this is a relative rating, and having a clone still isn't as cool as having an original.
- **1 point** if it runs the Macintosh operating system. (If you have a problem with this you're reading the wrong magazine. Go play *Descent II*, it'll make you feel better.)
- **1 point** if your computer is an all in one design. Still as cool as the day it was born.
- **1 point** if both a keyboard and a monitor came with your computer. Selling incomplete machines is not cool. Pretending you can buy a computer for \$999 when it really costs \$1400

is also not cool.

- **1 point** if it has an internal hard drive. I learned my “Mac SE with two 800k floppies” lesson. See below if you have an automatic floppy changer.
- **1 point** if it has a pre-installed CD-ROM drive.
- **1 point** if it has a PowerPC inside.
- **1 point** if you can turn your computer off from the keyboard. This is way cool.

## Points for your Stuff

---

- **1 point** if you have a printer attached to your computer.
- **1 more point** if your printer is a laser printer.
- **1 more point** if your printer is a color printer.
- **1 point** for every other peripheral attached to your computer. This includes stereo speakers (not built in speakers), external storage devices like hard drives or tape drives, modems, CD-ROMs, a coffee pot, whatever. Sorry, your mouse doesn't count.
- **1 point** for every 8 MB of RAM (or fraction thereof) installed in your computer.
- **1 point** for every accelerator card installed, making your Mac faster than others of its ilk. This is a colossal expenditure of money, and deserves some reward.
- **1 point** for potential coolness if your computer has empty expansion slots.
- **1 point** if your computer is part of a local area network (LAN).
- **1 more point** if that LAN is purely infrared (i.e. no wires involved)

## Points for Blatant Excess

---

- **1 point** for every 100 MB of unused internal hard disk space. (Zip disks do not count, for all intents and purposes they are like floppies.)
- **1 point** for every extra monitor attached to your Mac.
- **2 points** if you've dispensed with a modem completely and use ISDN instead. Add another point if you can get your GeoPort pod to do anything useful. (Doorstop does not count, but using it as a puppy's chew toy does, your indifference is cool.)
- **1 point** if your computer answers your telephone on a regular basis.
- **1 point** for each additional processor in your computer. That includes the DOS on Mac card from Reply Corp. and PowerPC upgrades that keep your original processor in place.
- **1 point** if you have foot-actuated rudder pedals for that complete flight simulation experience. Your single-mindedness is legendary.
- **1 point** if your Mac actually answers when you talk to it.
- **1 point** if you have the Apple TV Tuner card and refuse to watch normal TV anymore. Add another point if you get CNN at work on your Mac.
- **1 point** if you have an automatic floppy changer.
- **1 point** if your monitor tracks you as you walk around the room. Not that I've seen this, but it would be cool, no?

## Points for Trying

---

- **1 point** if your computer is over five years old, and yet you still use it regularly. (Keeping important papers from blowing away in a stiff breeze does not constitute regular use. An aquarium-converted Mac, ala Andy Ihnatko does count.)
- **1 point** if you still haven't upgraded to a color Macintosh.
- **1 point** if you have resisted owning a Microsoft compatible machine too. It's okay if they force you to use one at the office, we can't punish you for the corporate nincompoops you work for.
- **1 point** if you think your Newton is so good, you don't need a computer.

- **5 points** if you still don't own a computer (and you're using someone else's to read this). It's getting to the point where ignoring the information superhighway (and its attendant metaphors) is retro-chic, and that's sort of French for "cool."

## The Bottom Line

My Ilici, when it was brand new (gosh, four-and-a-half years ago now) had a Coolness Factor of merely 11 points. When I did this column a year ago, it had a coolness factor of 14, considerably better. Today, Pokegenia is 16 points Cool. In another half a year or so, she'll get another point for being five years old. If I compare that with my dream system, an 8500/120 with bells and whistles I end up with about a fifteen point difference. It's time to upgrade. Of course, I've known that for a while now. For what I'm willing to pay, about \$2,000, I could get a Performa 5215CD, with a Coolness Factor of 24. So yes, I should upgrade. Ta-da! Now I only have to pry that \$2,000 out of my budget somewhere.

Last year when I ran this test, the new system I could afford had the same coolness factor as Pokegenia. Today the story is different. But after all, it doesn't take rocket science (or a cool quiz like this one) to figure out that it's time to upgrade from a Ilici.

Try it out, and let me know what you think.

## About the Mother Ship

There's one site I check almost daily, if I can, and that's MacWEEK's web site. But skip the long download of the cover page, and go directly to the news page for up to date incisive news at <http://www.zdnet.com/macweek/news.html>. There's also one of the best sites about the workings of Macintosh, in Ric Ford's MacInTouch site, at <http://www.macintouch.com>. You'll find very up to date information on bugs, crashes, releases, and whatever you need to know to keep your Mac running smooth. If you're looking for solutions to your broken Mac, you can't do better than the Sad Macs, Bombs and other Disasters site, at <http://www.oakland.edu/~london/leadmac>, a site devoted to identifying and solving

common crashes and failures.

## Zealous Surfing

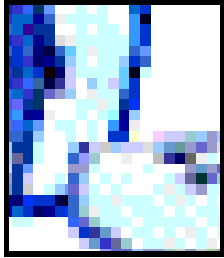

*A Comparison between Netscape Navigator 2.0.1 and Microsoft Internet Explorer 2.0b3

I've been using Netscape since it first became available for the Mac. I've seen it evolve over the course of various revisions and public betas, so I am very familiar with the way it works. Netscape Navigator is the web browser that I, and most other Mac users are most familiar with, so this article will attempt to introduce you to the differences between Microsoft Internet Explorer and Netscape. It should be noted that Internet Explorer is still in Beta form, and as such, its feature set is not yet complete. It currently lacks support for security, and for frames.

## **They're Both Browsers**

Both Internet Explorer and Netscape are World Wide Web browsers. For many sites, it does not matter which one you use. They both support the complete HTML 2.0 specification, and they share a common plug-in architecture. Both browsers support helper applications such as Stuffit Expander, and NCSA Telnet to further expand their capabilities. They also have similar ways of integrating these helpers into the web experience. They even have remarkably similar preferences and options that you can set.

## **Two Different Interfaces**

While it's clear that the folks at Microsoft used Netscape as a model when creating Internet Explorer, the two have distinctly different interfaces. Netscape has a nice beveled grey toolbar, which looks like something you would find in Copland, the next integral release of the MacOS. It contains standard browser buttons such as Back, Forward, Print, Open, Find, and Home, and there are several options for configuring it. You can choose to view the buttons as text, as graphics, or to have them disappear completely. In addition, you can optionally display a set of buttons which are a sort of permanent bookmarks. These include such things as an Internet Search, What's New, and What's Cool. I don't display these buttons because they take up screen real estate. They are valuable resources though, and are available in a menu if you need them.

I'll have to admit that I didn't expect much in Internet Explorer's interface. I was a die-hard fan of Microsoft Word until Word 6 set new standards in bloated interface design and slow code. At first glance, Internet Explorer looks just like any other Microsoft product. It has the



Word/Excel style toolbar with those tiny square buttons that I find annoying to click on. Rather than having text on the buttons, Internet Explorer covers them with tiny icons, some of which I don't think are very self explanatory.

You have a choice between a Netscape style toolbar, which contains the same buttons as Netscape, but in an iconic Microsoft style, and a Microsoft layout which includes several extra buttons. Neither arrangement covers the full width of the browsing window, which makes me wonder why they didn't make the buttons larger. Also, since Microsoft cloned the toolbar's look from their other products, I wonder why they didn't make it completely customizable. Finally, I'm not sure why Microsoft put cut, copy and paste buttons on the toolbar. Does anyone use these? Keyboard equivalents seem much faster to me, and since people only copy text from web pages, the cut and paste features seem to be excess buttons complicating the interface.

The main browsing windows in Netscape and Internet Explorer are remarkably similar. Both programs have a small progress bar in the lower right hand corner of the window, and both have a status area in the lower left hand corner that shows information such as where the current link will take you, and some information about the file currently being loaded. Internet Explorer wins here. It's progress bar moves much more smoothly, and seems to be a better indicator of how much time it will take to complete the page. It also has a hot help area here, similar to the one in Word and in Excel that offers a balloon style help in the corner of the window. This is much faster, and more responsive than the sparse balloon help in Netscape. However, Netscape has better help documentation, and they have a number of good web sites accessible through the Guide Menu to help explain things to you.

One thing about Internet Explorer that I don't like, is that the command for opening locations and files is the same. Thus, if you want to open a file, you have to select open, and then click on the open file button. This two-step approach could be alleviated by making them two separate commands as they are in Netscape.

## Using The Browsers

Both web browsers take up a fair amount of space, especially if you count their helpers. Netscape alone takes up 2.6MB in fat binary form, and Internet Explorer takes up 1.5MB. They also both have large RAM requirements. Netscape suggests 3000K, while Internet Explorer suggests 4000K. Neither of these RAM allocations is enough if you plan to have more than five complicated web pages open at once. Also, if you plan on using Macromedia's Shockwave plug-in, you should increase the RAM allocation of either product to 8000K.

Internet Explorer is significantly easier to configure than Netscape. It offers to automatically import your Netscape bookmarks into its Favorites list, and also can copy information such as your name and email address from InternetConfig.

## Viewing Web Pages

There are basically three factors for comparing how various browsers display a page: how long it takes, what it looks like when finished, and what it looks like while in progress. As far as final quality is concerned, Netscape is the hands-down winner. It seems to reproduce font sizes and graphic layouts much more faithfully than Internet Explorer, which seems to judiciously add blank space between graphics, and between lines of text. Netscape also handles image errors better. When a graphic cannot be loaded, it replaces it with a broken picture symbol. Internet Explorer brings up a rather ugly and generic dialog box, notifying you that the image couldn't be loaded.

Speedwise, Internet Explorer is the winner. In my informal timings, it seemed to be about 30 percent faster than Netscape at loading pages. Internet Explorer is also better at displaying pages while they are loading. Netscape takes more time to initially display a page, and when it does, it loads text and graphics at the same time. Internet Explorer displays pages in two passes. First, it displays the text of the web page, with image placeholders. This step happens almost instantaneously. Then it goes back and loads all of the graphics, displaying in the status area exactly what type of image it is receiving. This results in a much more responsive web experience, and is I think the greatest advantage that Internet Explorer has over Netscape.

## Downloading

The ability to save files and images to your hard disk for later retrieval is one of the most important jobs of a web browser. Netscape triumphs in both of these areas. Both Netscape and Internet Explorer let you download a file by choosing a command from a popup menu. If you click on a link to a file, Netscape will open a new downloading window, allowing you to continue browsing in the window you were in. This downloading window is significantly smaller than a normal browsing window, and resembles the Finder's copy window. Netscape also supports drag and drop, letting you simply drag an image or link into a folder, or disk, in the Finder. By contrast, Internet Explorer forces you to tie up a large window for downloading each file. Granted, you can resize it if you want to, but Netscape's method is far more elegant. Also, Netscape gives you full statistics about how the file is being copied. It tells you the size of the file, the estimated time remaining, and the percent complete. Internet Explorer only tells you the size of the file.

## Bookmarks and Favorites

Functionally, Netscape's Bookmarks and Internet Explorer's Favorites are basically the same. However, there are several things that make Internet Explorer's Favorites superior. It consolidates all the commands for manipulating and adding Favorites into one menu. To edit Bookmarks in Netscape, you must first go to the Windows menu to open up the Bookmarks viewer and editor. Then an Item menu appears, letting you edit Bookmarks, and add dividers, bookmarks, and folders. This is a bit cumbersome, and is also slower than Internet Explorer.

Internet Explorer keeps a detailed history of all the web sites that you have visited, and preserves this between launches of the program. It also provides an easy method for revisiting items in the history, and adding them to the Favorites list. However, both programs could learn from Apple's Cyberdog, which has a much better way of keeping track of bookmarks, and dynamically resolving them. That is to say, if you bookmark a link before visiting it, the bookmark's title will change to the title of the link's page after you do visit it.

## Mail, News, and FTP

Both Netscape and Internet Explorer include these tools. Both have minimal mail clients that are slow, but useful if you want to quickly write to someone referenced on a web page. The newsreaders aren't really worth using, as most shareware newsreaders are faster and more powerful. While neither Netscape, nor Internet Explorer includes an FTP client that can rival a stand-alone product, I prefer Netscape's, because it displays icons, and because it makes navigating directories somewhat easier than Internet Explorer does.

## Final Words

At this moment, the choice between Netscape and Internet Explorer is easy, because Internet

Explorer does not yet support frames or security features. However, this will change, when Microsoft issues the final release. When this happens, the choice will no longer be quite so easy. Despite its comparative sluggishness, I recommend Netscape to everyone. It is the standard for web browsing, and 85% of all people who use the web use Netscape Navigator. It offers superior capabilities for downloading files, and it is the only browser that is guaranteed to view pages correctly.

Internet Explorer is a much more responsive browser, and is also faster for most tasks. It has slightly better bookmarking capabilities than Netscape does, so if either of these is important to you, it is worth a try. It is not yet however, a product that can rival Netscape as the browser for the masses.

If you need more advanced features, or integrated bookmark and history features than either of these programs offers, I suggest that you take a look at Apple's Cyberdog. Cyberdog is a collection of Internet components, all of which are integrated with a bookmark list and with the MacOS. It is still in beta form, but offers an impressive set of bookmarking tools.

Also worth a look is the Netscape Navigator Atlas Preview. This is a publicly released version of an early Beta of Netscape 3.0. It improves on the current Navigator by adding support for Java, better navigation in frames, more compact downloading windows, InternetConfig support, better help, and more. Be aware though, that it is beta software, and therefore is not as stable as the less featured Netscape 2.0.1.

You can try Netscape, Atlas, Internet Explorer, and Cyberdog for free, simply by downloading a copy from Netscape's, Microsoft's, or Apple's web pages respectively. The best way to decide which browser to use is simply to try out a demo for a few days to see how it fits in with your surfing style.

# FileMaker Pro comes of Age

It was a beautiful day in Burbank. The sun was shining. The air was uncharacteristically clear, and our FileMaker disks came back from Claris. The fine folks there were able to successfully recover our data. This meant that our sweating brows could finally be matted, and we knew once again at a glance who owned the distribution rights to each of our motion pictures in every territory throughout the world.

Life with FileMaker and then FileMaker Pro seemed to alternate between a swooning dance with death, and the awkward first steps we each took at that first Junior High School dance after spending most of the night gawking at our future dance partner from across the gym floor.

In fairness to Claris, some of the problems had little to do with the software. As Mac users we were accustomed to being spoiled. FileMaker always seemed, in a phrase, “unMac like.” In some ways using FileMaker represented the fledgling emergence of the Mac from just a niche machine to a more complete small business solution. We were used to simply clicking, scrolling, and using preformatted layouts and windows. By definition, FileMaker, like any database application that was intended to be versatile, required the user to preplan, to format the layouts and windows, and to develop how data was to be inputted, displayed and manipulated.

At the time FileMaker wasn't our favorite database application for the Mac, it was, for the most part, THE database application for the Mac. While many of us would spend a year learning the ins and outs of Photoshop, very few of us would want to spend even a month learning the basic ins and outs of FileMaker Pro. The thought of developing a database wasn't something that got most people up and going in the morning. Again, in fairness to Claris, the technical support staff always seemed to be extraordinarily helpful to anyone who made an earnest effort to learn and understand the software.

One of the problems with FileMaker and FileMaker Pro was that they were always exceedingly fragile. FileMaker documents, prior to FileMaker Pro version 2.1, required intensive care, especially if a file was accessed by more than one person over a rudimentary network. There were times that we would make intra-day backups of our FileMaker documents because the files

were so easily corrupted. We were constantly “recovering” the data.

Secondly, the documentation that came with the application wasn’t easily understood. Thirdly, because it wasn’t “relational,” (more on this a little later) the uses were either somewhat limited or the amount of layout design work required for each file seemed overly burdensome.

For those of us who were good with spreadsheets we would often adapt a spreadsheet to perform a particular task or role rather than deal with the intricacies and fragility of FileMaker. FileMaker was relegated for use in only specific data management roles, rather than used as the full-service database solution it was intended to be.

## This is Now



The good news, is that was then, and this is now. FileMaker Pro 3.0 is now what many of us had long-hoped it would be: a true database solution for the Macintosh platform. (There’s a Windows version too.) After several years of prior versions, working with FileMaker Pro 3.0 is no longer like asking for directions to that small town in northern New England. Yes, now you can get there from here.

For anyone considering purchasing a database application for the first time, FileMaker Pro 3.0 is well worth the \$199.50 street price admission. For starters, the documentation is solid. The tutorial provides a very nice overview of working with the software, and many of the templates can be easily modified to provide almost immediate solutions to your data management requirements.

For those of us that have used FileMaker Pro before, the new version is like visiting with an old high school friend after both of you graduate from college. Your outlooks have changed, your needs and desires are a bit more sophisticated, but you’re surprised at how easily you can relate with one another on important new issues of the day, while still fondly remembering the times you shared when life was seemingly less complicated, and more carefree. The upgrade, at \$99.95, is less expensive than your final college class and more fun than cutting the math test in high school.

I make my living consulting small businesses on finance and accounting. People hire me usually because they can’t afford full-time accounting personnel. With FileMaker Pro 3.0, I can offer clients two important options. I can setup and maintain their database, or I can walk them through the setup and help them to easily maintain the database themselves.

For new and experienced users, the most compelling change in FileMaker 3.0 is that it is now “relational.” This means that information such as names, addresses, and product information are no longer copied from one FileMaker Pro file to another. Information can now be shared from one file to another. Redundant data no longer needs to be stored.

For example, if my company sells a product, I create an invoice for a customer transaction in my invoice file, but the data about what was sold is stored in my sales line item file. The invoice file has a “portal” or window which displays the information unique to that transaction from the sales line item file.

This makes it easier to create sales and product reports, because the file which maintains that data (the sales line item file) can be designed more freely for my custom reports, and because the size of my invoice file is much more manageable and less encumbered because the sales information no longer needs to be permanently stored there. The customer information can also be stored in a separate file.

FileMaker Pro 3.0 will still require the new user to spend some time becoming familiar with the application, but for \$199.50 the time spent is now a worthwhile equity investment in your business.

For me and many of my clients, our databases are constantly honed and revised as needs and business circumstances change. FileMaker Pro data is easily exportable to other applications. I often export data to Microsoft Excel for one-time reports, or to experiment with different ways of manipulating information before creating more permanent reports in FileMaker Pro. This provides me and many of my clients with the best of both worlds—you can use your FileMaker Pro data in different applications for different purposes, or you can ultimately design a layout and report in FileMaker Pro on your time schedule to provide the appropriate information.

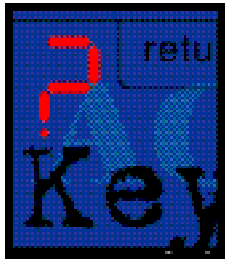
For small businesses that can't afford full-time accounting or data management personnel (we do live in the real world of paying the rent and feeding our families) this provides an opportunity to have your information now, and to revise your FileMaker Pro file later as needs and time permit.

For experienced users, Claris offers an excellent tutorial devoted expressly to building relational databases for about \$30. I followed the tutorial step-by-step and was amazed at how quickly I was able to make the adjustment to “relational thinking” in building new databases, and in converting older ones.

FileMaker Pro is no longer like that swooning dance with death for your data, or like when the music stops that first time in the Junior High School gym and you're less than gracefully trying to exit the floor hoping not too many of your friends saw you out there trying. FileMaker Pro 3.0 is more like: “Wow!, that data dance was cool. Let's see what happens when we try to tango!” Kudos to Claris on this one. Investing in FileMaker Pro 3.0 is money well spent.

# Comics

---

Cartoons and comic books have been part of American culture for over a hundred years. First appearing in newspapers and magazines in the late 1800s, cartoons have been bringing laughs and social commentary to the masses on a regular basis ever since. Who doesn't remember asking for the "funnies" section of the Sunday paper when it arrived? Or going to the local drug store to buy a favorite comic book? These things are part of our heritage.

Along with the computer revolution, came the publishing revolution. Individuals no longer need to rely on a publishing company or newspaper to express their ideas. Anyone who owns a computer and has access to the internet or to a commercial online service can be a publisher. By simply creating a publication in a digital form and then uploading it, the author has reached a potential audience of literally millions of people. Because of this "freedom of the press", there has been an explosion of comic books and cartoon strips of every conceivable type. I went online to see what I could find. Here are some examples.

America Online has several comic-related forums containing a wealth of information for the enthusiast. DC Comics, Dilbert, and political satirist Mike Keefe each have their own forums. These forums typically contain message boards and live chat rooms for discussing popular topics. Plus, you can usually find old comic strips and original artwork available for downloading.

Those interested in the history of comic books should check out the Comic Strip Centennial Area. This area was created in honor of the 100th anniversary of cartooning in America. Cartoon history students will be off to a good start after reading profiles of the Hall of Fame cartoonist. These profiles are part of the Hall of Fame exhibit that will soon be on display at the International Museum of Cartoon Art, a brand new 52,000 square-foot facility now under construction in Boca Raton, Florida. The Hall of Fame was established in 1975 to honor lifetime achievement in the cartoon art form. Twenty seven artist are profiled by Brian Walker, creator of the Hi & Lois comic strip. The profiles span the past hundred years, from early pioneers like Rudolph Dirks (Katzenjammer Kids) and Charles Dana Gibson (the "Gibson girls"), to contemporaries such as Walt Disney, and Charles Schultz (Peanuts).

If you think you have what it takes to be a DC comic artist, a set of submission guidelines is available in the Disclaimers/Notices/Guide section of the DC Comics forum. Thorough, helpful information concerning DC's requirements will prepare you to submit a professional



demonstration of your work. There are tips concerning artwork covering pencil, ink, lettering, and coloring. Plus story submission guidelines. Did you know stories are judged based on a story “Springboard”. A story “Springboard” is a one page story concept containing five elements: a beginning, a middle, an end, a hook, and reader identification. Include more than this and it won’t even be read. Hey, no one said fame and fortune would be easy.

If you’re really the independent type you might consider going into syndication. Syndicates sell the work of cartoonist to magazines and newspapers, splitting the profits with the artists. One of the world’s largest syndicates, King Features, has a set of submission guidelines also. The competition is tough. King Features receives over 6,000 submissions a year. However the rewards can be sweet. Depending on how many newspapers subscribe to your comic strip and other products created based on your characters, you could conceivably pass the \$1,000,000 a year mark. Just ask Charles Shultz, or Gary Larson.

When it comes to the Internet, comics rule! There are hundreds, perhaps thousands of web sites devoted to comic books. The number of independent comic publishers is staggering. One site you may want to visit is The Comic Book Net at <http://members.aol.com/ComicBkNet>. The Comic Book Net publishes a text only electronic magazine called THE COMIC BOOK NET ELECTRONIC MAGAZINE which is jammed full of news, reviews, new releases, and addresses of current comic-related web sites. Another helpful site is the Comic Book Depot (<http://www.insv.com/comxdepo/comxlinx.html>). Here you can find alphabetically arranged links to many comic publishers, art galleries, printers who specialize in comic printing, news and discussion groups, and dealers.

If your love of comic art outweighs your desire for monetary gain, you can always publish your artwork for free. This is exactly what several artists do. Although they go about it in different ways. Many artists upload comic “pages” as graphic files— usually in GIF or JPEG format. This is an easy way to show off your creations. All that is needed by the user to read the comic is a graphic viewing application or a paint program. Below is a comic page graphic by Todd DeMelle (<http://users.aol.com/ejwize/>) entitled “House of Asterion”. Todd created the ink drawings by hand, scanned them into PhotoShop and added the color. He then uploaded the page as a JPEG file.



Dana Muise has taken a different approach to comic book publishing. Dana has created a shareware comic viewing application called Brain Box Comics. Sort of a digital comic book, this



application is unique in the fact that comic strips are saved as “story” files that can be opened by the application. Authors are encouraged to submit comics to Brain Box and new stories are uploaded to America Online and the Internet. Take a look at the unique interface of the Brain Box viewing application.



Comic art comes in many forms, including icons. That’s right, you can replace that old hard drive icon with a snappy new Spiderman one. Or maybe you would prefer Tweety bird. Here are some samples of icons I found online.



If you are creating your comics digitally, you may want to consider some of the many comic fonts available. Katherine is a freeware font designed by Don Miller. It resembles the lettering used in the comic strip Kathy.

# Beauty and the Beast

**THE DIFFERENCE BETWEEN A BEAUTIFUL DESKTOP AND ONE IN PERIL**

One thing about us Mac users; we do more system tweaking than any other OS users. That's partly because it's so easy, and partly because part of the Mac experience is that your computer is as individual as you. I don't know about you, but I no longer even refer to "my computer" as my computer. I call it by name, "Tiberius." When absolutely necessary, "My Mac." I cringe when I slip on this point.

In the process of tweaking, the beginning and intermediate user can stumble upon many freeware, shareware, and retail solutions for customizing the desktop of your best friend. Many of these are well-written, excellent programs for creating a new look on your screen.

Some, on the other hand, are just downright dangerous.

There are tricks to knowing the differences between Beauty and the Beast, and they are all very

simple. We'll discuss those, plus ways in which to guard your system from dangerous additions that could mean computer chaos. So without further ado, here are some ways of determining how to safely beautify your Mac's desktop.

## Show me how you do that trick...

Oof. Bad song, unless you're into The Cure. Anyway, the main trick to knowing the difference between Beauty and the Beast is easy. Ask yourself a few questions. What is it? Is it an application? A control panel? An extension? Does it use a Res Edit-type utility to hack into system code? The answers to these questions will give you hints about how much trouble you might be getting into.

## Extensions and Control Panels (CDEVs)

Extensions and control panels are great ways to put your system in danger. Unless written by major software vendors or Apple Computer itself, they often cause crashes and freezes. They even do it sometimes when they are written by major software companies. After Dark is a great example. Worse, they are almost always memory hogs that will slow down your computer's performance.

I know what you're thinking. The coolest customizers are extensions and control panels, right? Cursor Animator, Aaron, After Dark, Wunderbar, etc. Unfortunately, this is true. It is also the unfortunate truth that they are usually the prime suspect in crashes on such systems. This does not by any means mean you cannot use them. Just know how to use them safely.

First of all, use your head. Do not install two extensions or control panels that do the same thing. They WILL crash the system. For example, using two different window-customizing extensions will cause the system to get confused and lock up in many instances. If you have to have one at all, choose your favorite, and store or trash the other.

Second, never install more than one such extension or control panel at a time. If you have Aaron, Cursor Animator, and After Dark sitting in front of you, waiting to be loaded onto your system, pick one ONLY, load it, and use the computer normally for a week. If no trouble crops up, you are probably safe to load another and repeat the process. But keep a note of when you installed it. If trouble comes up later, you'll want to disable all the non-system 7.X extensions first, and add them back in one at a time to see who the culprit is. Lots of fun, right?

I want to make a quick note here that many of the programs I mentioned are the result of lots of hard work and programming expertise. The programmers of these extensions and control panels know their stuff, and I do not in any way intend to besmirch their products or abilities. However, the programmers are incapable of seeing every possible system configuration, since literally millions are possible. There are other extensions out there that they are unaware of. They don't realize that something you have on your computer might well be asking the computer to perform a similar task simultaneously, thus causing a freeze. It is for this reason that I issue this warning, and no other. I use Aaron myself, and it works beautifully. But that might change in the future, depending on what I add to the system.

## Applications

Applications that run in the background and beautify your Mac are rare. They consist mostly of either self-launching or manually-launched screen savers. They are, for the most part, completely safe. This is because they open and close, leaving the system software more or less

alone, and asking for memory only when they are running. FirePower is a shareware screen saver that runs a single module (fireworks), is self-launching, and completely stable on four systems I've tested.

Another such program is called Christmas Lights. It puts little light bulbs around the perimeter of your screen and plays Christmas music in the background. Not much good for summer, granted, but you get the idea. It runs on five or six hundred kilobytes, and is completely non-intrusive. Programs like it should also be safe.

Again, you won't find many programs that fall under this category, but rest assured that when you do, they will be safe 99 out of 100 times. If they aren't, all you have to do is restart and never open them again. You'll know immediately if they are causing trouble. Much neater than extensions.

## Res Edit-Type Hacks

I am going to take a beating for this, and I am prepared for it, but it is my opinion that unless you have some basic knowledge of toolbox calls, lower-memory globals, event queues, and the like, you should never, ever use a hack into your system software. If the references I made above to domains and actions of the system software are totally foreign to you, then I have made my point. I don't care if it comes with instructions on how to use it. Chances are good that you can miss something, delete something, or change something that is not meant to be changed. This can cause a catastrophic error of the kind that doesn't even let you start up. Sound like fun?

Why does this happen? Well, when you use a "hack," as they are often called, you are essentially rewriting parts of system code. While Res Edit itself always reminds you to work on a copy of a resource rather than the original, this hardly matters once you've restarted with a hacked system file. Sure, your original is still there, but you'll need to load your disk tools to get to it. If you were unlucky enough to work on the original, guess what? Time to reinstall the system software. And we all know how much fun that is, don't we?

This does not mean that Res Edit is evil. It means simply that you should stay away from your system file. Apple gave you a way to modify the system, and that way is called extensions. And they can be trouble enough. Why make it worse? Res Edit is wonderful for changing font IDs to avoid conflicts and so on, but keep it away - far away - from anything having to do with your system software.

## Okay, Adam, what *can* I use?

Don't misunderstand this article. With the exception of the hacks, I am not rejecting any way of beautifying your Mac. Using these programs, however, becomes a responsibility. You owe it to yourself to use them wisely, knowing to disable them first when trouble arises. As I said, I use Aaron, and it runs flawlessly on my 7500 and my 520c. My brother loves running it on his 540c, but his 7100 does all kinds of silly things if he tries to run it. The same thing was true of my old 660AV. It just depends.

But I refuse to be vague in this article, because I hate it when writers pat you on the head, say "be careful," and then push you into traffic. So here is a short list of beautifications that I feel will work safely on your system, for at least two-thirds of the users out there. By the way, I make no claims as to the validity of this opinion for any specific system, it is a generalized opinion. Also, you must still remember to be careful when using these programs simultaneously:

Aaron 1.2 (custom desktop interface), FirePower (screen saver), Christmas Lights (holiday cheer), Desktop Textures (desktop patterns), Apple's Desktop Patterns (a desktop pattern installer that's about as safe as you can possibly get. It comes with system 7.5 or better) any icons (easiest when the picture actually stands for the folder, not when it comes as a Res Edit file), any sounds (note that you'll need a utility to convert .WAV files, which are PC-based sounds. Brian's Sound Tool, available on AOL, is good for this), fonts appropriate to your printer (unless you have PostScript software or a PostScript printer, PostScript fonts will not print correctly on your printer. You'll need TrueType fonts instead.), and most background and startup picture utilities.

Most of these should be available on AOL, at the keyword "download" do a file search for the product. Christmas Lights is not shareware however, you'll have to buy that in a store. The items that are shareware or freeware may also be available on other services and local bulletin board systems. Please remember to pay shareware fees if you use a product. It doesn't matter if you've used it for two years already. Don't be embarrassed. Once the programmer has your check, he'll be all too happy to forgive your oversight. Giving these good people our money assures that they'll give us more cool stuff in the future, often for free, just because they love programming.

Before I close, I'd like to mention another little program that could be construed as beautification. It's called Rainbox, and is freeware. It is one of the most addictive little art programs I have ever owned, and is not only free, it is safe for your Mac. It is a short download, and will keep you happy and occupied for hours. Download it, e-mail the author, and thank him profusely. You'll be happy you did.

Customizing your Mac isn't just something you should consider. It's a duty. Do it responsibly, and you might even find that your productivity increases as a result. If nothing else, your enjoyment of your Mac will.

# Interactivity

As I write this, it's April 6th, 1996, and I just received my shredded copy of Interactivity magazine in the mail, the May issue. Significant for two reasons: A) There's a review of Adobe Pagemill, and 2) The post office tried to cover its tracks by taping the magazine back together. Another fine example of your tax dollars at work. Ok, so the post office is fully privately funded, but you get the idea. As this is the 'Web issue' of ATPM, I'm hoping this will all become relevant. One day soon, in the middle of the night, you'll wake up in a cold sweat, and say to yourself, "Of course, what Mike was babbling about all makes sense now!"

## The Hughes Wide Web

Set your browser to <http://hww.hac.com/>. Wait, you can't get there from wherever you are. Why, you ask? Because this is the new thing that companies are doing, it's called an Intranet! We have several web pages, and a few full time web page developers, that tell everyone about the wonders of life at Huge. Now you, as mere mortals, can't get to this information, because it's proprietary, and sits behind a firewall. Don't take this as a challenge, you won't be able to break it.

I know.

I've tried.

Alas, that is another column. Anyway, to get to the Web proper from Huge, before a month and a half ago, you needed to do the following: First, fire up MacX (version 1.5 for the 7200's, however we talked about those last month), next run NSCA Telnet, and login to igate1 (this is the firewall I told you about). Answer: Well, well! My first satisfied reader! Too bad I don't have an answer for her! But seriously, I'll be the first to admit I've never used a Classic II, however, I do love the detective work. My guess would be that the memory partition of the program(s) in question would be the culprit. To increase this, simply do a Get Info from the File Menu (or command-I) on the program in question while you're in the Finder. This will give you a box that tells you all sorts of wonderful things, including how much memory should be required to run your program. Simply highlight the numbers in the boxes, and enter a larger number. Lately, at Huge, we've been running Gatesware, which is a real memory hog, so I've been cranking up the memory requirements of Word, Excel, etc. to twice what Bill recommends. Further info available at [AskBill@Microsoft.com](mailto:AskBill@Microsoft.com). If this doesn't work, the simple solution would be to buy a new Mac. I hear the 7200's are really good.

I have read several "solutions" to this problem, but they all involve turning off or disabling Open Transport. I can't do this, since I use the local-talk network to print and to network with two other computers. And I can't switch to "classic AppleTalk" because it's not supported on my machine. Perhaps you can help me! Do I have some of my facts wrong, or am I approaching this wrong? Do you know how I can get connected to the Internet with my Power Mac 7500/100?

I am using System 7.5.3. My modem is a Global Village Teleport Platinum. I have lots of RAM and hard disk space. I use Now Utilities and QuicKeys and a Kensington Turbo Mouse. (I'm giving all this info just in case it raises any red flags vis-a-vis Internet connecting). Thanks a million! Sean in Ben Lomond

Answer: Well Sean, it seems like you have the latest and greatest in hardware and software, and I like that you're running 7.5.3 with no problems(?) As you know from my trials at Huge, my exposure to this type of problem is limited, however, you said the magic word when you mentioned Open Transport, in conjunction with 7.5.3. This would imply that you're running version 1.1 of OT. If you aren't, this is your problem. Again, you can "Get Info" on Open Transport, which is hiding in your Extensions folder, I believe. Somewhere in the middle, or even at the top of the info box, it should tell you the version of Open Transport you're running. Then it's simply a matter of getting your ISP to provide you with the proper info to put in the proper slots. It would be really cool if I could put a screenshot here, to help you out, however, my column's late, and I don't have access. Anyway, if this is not the problem, you may have an extension conflict rearing it's ugly head, and I explained how to resolve those last month.
